Payment regulation

Dear parents,

hereby we inform you that in accordance with the Learning Agreement Appendix 2 Tuition Fee (Payment conditions) Clause No.1 Basic Tuition Fee, the legal representative is obliged to pay the tuition for the sixth – ninth grade in the school year 2023/2024 as follows:

- a) 200,00 EUR monthly in case that the number of pupils is between eleven (11) and sixteen (16),
- b) 240,00 EUR monthly in case that the number of pupils is less than eleven (11).

In case that the pupil has a sibling in a higher grade, in accordance with the Learning Agreement Appendix 2 Tuition Fee (Payment conditions) Clause No.7 Discounted Tuition Fee the legal representative is obliged to pay the tuition for the sixth - ninth grade in the school year 2023/2024 as follows:

- a) 150,00 EUR monthly for each sibling of a SSŠ pupil who attends a class with the number of pupils from eleven (11) to sixteen (16),
- b) 180,00 EUR monthly for each sibling of a SSŠ pupil who attends a class with the number of pupils less than eleven (11).

Pursuant to Learning Agreement Appendix 2 Tuition Fee (Payment conditions) Clause No.11 Basic Tuition Fee for a pupil in sixth – ninth grade is increased by 50 % of the Basic Tuition Fee or the Discounted Tuition Fee, if the pupil is a foreigner and has no command of Slovak Language.

The Enrolment Fee for the school year 2023/2024 represents the sum of 200,00 EUR. Pupil's legal representative is obliged to pay the Enrolment Fee within five (5) days from the effective date of the Agreement.

- accident insurance of pupils, insurance of pupils' personal property,
- innovation trends and methodologies in educational process,
- system of monitoring of emotional intelligence, general intellect and level of knowledge of students through testing methods,
- individual approach of the teacher due to maximum 16 pupils in the classroom
- partial payment of costs for the teaching of second compulsory foreign language from sixth grade –
 Spanish Language, German Language.

The Tuition Fee does not include the costs of:

- activities and teaching carried out by the third parties (including the teachers of foreign languages) who are not employees of School and provide the education of the Pupil in **facultative English School Club**;
- pedagogical-educational activity carried out by employees of School and/or third parties who are not employees of School and provide interest-based education for pupils within interest groups of Private Leisure Centre,
